## 01. Welcome, Present & Apologies

- 01.1 The Chair opened the 42<sup>nd</sup> Victorian Farmers Federation (VFF) Annual General Meeting at 11:49, after waiting on a quorum to join the AGM
- O1.2 The Chair welcomed all members, directors and staff, along with Audit Partner, Tony Pititto and Audit Manager Hai Hoang from Grant Thornton.
- 01.3 No apologies were received.

### 02. Quorum

02.1 It was **agreed** that the 42<sup>nd</sup> VFF AGM could proceed as there was a quorum present of 29 members either at Farrer House, via zoom and via phone in addition to 5 valid proxies received.

#### 03.1 Minutes of the 41st VFF Annual General Meeting held on 24 February 2020

- 03.1.1 The Minutes from the 41<sup>st</sup> VFF AGM, held on 24 February 2020, were **accepted** as an accurate reflection of the meeting, pending the following changes:

### 04 President's Report

- 04.1 The President's report was taken as read.
- 04.2 The Chair gave thanks to loyal VFF members and introduced the newly employed VFF CEO, Jane Lovell.
- O4.3 Jane Lovell said she is looking forward to meeting and working with members and thanked the VFF Executive Board for the opportunity to be the VFF CEO.
- 04.4 The Chair told members that Strategic Planning will now restart now that Jane is on board.
- 04.5 The Chair of the Finance and Audit Committee took the Chair and addressed members.

## 05 Chair of the Finance & Audit Committee's Report

- O5.1 The Chair of the Finance & Audit Committee took his report as read, he then spoke to members about the financials of the VFF:
  - There have been issues in what was a difficult 2020; The Melbourne International Flower &
    Garden Show was cancelled and Farrer House income declined with rental relief due to the global
    pandemic.
  - As the VFF met all requirements of the JobKeeper program, the VFF received benefits of the program up to the end of 30 September. This will not carry forward into 2021.
  - Farrer House is a great legacy asset and will see us through the current period. Refurbishments are underway on various floors in the building, this will provide larger floor space and a more attractive option to organisations looking to downsize after the pandemic.
  - The VFF is looking to grow membership for long term financial sustainability, this will be worked on both by staff and the board.

#### 08 Questions and Close

08.1 The Chair opened for guestions from members:

**Q:** VFF Member Georgina Gubbins asked what the proposal was to increase membership:

**A:** The Chair told members that Strategic Planning needs to be completed. Work would be done with regard to auditing the organisation and membership processes to get an understanding of the value of VFF membership and why people are not VFF members, along with looking at better communication and transparency.

08.2 **Q:** VFF Member Peter Small – made a statement about frustrations for members with regards to being able to partake in policy formation, that current branch system is not adequate engagement to contribute meaningfully to VFF positions.

**A:** The Chair agreed that this is an issue and told members that she would like to see the organisation remaining grass roots along with looking into how we can better communicate with members and a part of that was looking at what technology is available. We will also be looking at ways to reinvigorating the branch system.

08.3 The VFF AGM was closed by the Chair at 12:15
