Job title Livestock Project Manager (Maximum Term Full Time – 2 Years)

Reports to Livestock Manager

Summary

The focus of the Livestock Project Manager is to work with the Livestock Manager and lead the VFF Stock Sense industry funded extension team to deliver animal health and biosecurity information to Victorian sheep, cattle and goat producers including peri-urban landholders.

Delivering a number of projects, the team provides information through events, publications and online content to help producers and livestock owners adopt animal health and production practices that improve profitability, animal welfare and Victoria's biosecurity status. Topics include:

- biosecurity practices at a livestock enterprise and industry level
- managing the risk of diseases, pests and weeds being introduced or spreading on-farm
- livestock traceability and industry assurance programs
- animal welfare standards and guidelines
- responsible and productive livestock management
- emergency response planning.

The role will be responsible for managing delivery of projects in-line with milestones and budget, maintaining a strategic approach and efficiently using the resources available to benefit Victorian livestock producers, using existing networks to help deliver project outcomes, motivating and guiding employees, and reporting to funding bodies.

Key duties and responsibilities

- a) Manage project delivery, providing strategic direction to ensure aims and objectives are met, and effective and efficient delivery in-line with milestones and budgets.
- b) Oversee development and delivery of project communications, branding and other outputs in-line with key messaging and a contemporary communication style.
- c) Be responsible for successful planning of events and workshops for producers and livestock owners, including using networks to develop relevant programs and brief speakers on local issues or topics while linking with state and national R&D.

- d) Maintain stakeholder and industry networks including government departments, industry organisations, research and technical experts, supply chain and livestock producers to support project delivery.
- e) Ensure effective project evaluation, adoption of feedback and continuous improvement in project delivery.
- f) Complete reporting and provide information to funding bodies and other key stakeholders.
- g) Facilitate reference group and stakeholder meetings.
- h) Supervise the extension team, prioritising activities, managing resources, task delivery and ensuring a positive working environment across multiple locations.
- i) Attend industry forums and meetings where appropriate.
- j) Represent and reflect the VFF organisation values at all times.
- k) Other duties as directed by the Livestock Manager.
